#### **Spring Walk Around**

During the last couple weeks of April, the board did the walk around assessment of common areas and exteriors in need of attention by the homeowner. At the time of this newsletter, things are looking quite good. The masonry work that required a good deal of time and money last year is noticeable, with very few walks still pending attention. The decks overall are in good repair. The homeowner of decks requiring attention will be receiving individual notification. Typically power washing occurs on an annual basis, rotating through 1/3 of our community. (1-40, 41-80, 81-120). This year, in an effort to minimize expenses, we have decided to selectively powerwash only affected facades. In most instances, the buildings' north facing facades require this attention. During the walkaround, members of the board are evaluating the need and will report it to Diana Salsberg who is getting estimates for this selective work. Siding repairs were identified and will be dealt with individually. Front gardens not in compliance with bylaws will be noted to respective individuals. Thank you for putting time and effort into your home's exterior maintenance to make the community look desirable for all to enjoy.



## **Minutes of Stonebridge Homeowners Board Meeting**

The meeting was convened at 3:01 PM on 4/4/2023 at 19 Prestwick Ct.

The following members of the Board were present: Donna Augustine, President; Martin Charwat, Vice – President; Steve Bartlett, Treasurer; Janet Ellsworth, Corresponding Secretary; Edie Stout, Recording Secretary; Brenda Berry (via Zoom), member – at Large and John Weisman, member-at-Large was excused.

The Board meeting went immediately into executive session in order to discuss a private financial issue. The motion to adjourn the executive session at 3:07 was made by Steve Bartlett and seconded by Donna Augustine. At 3:08 Martin Charwat proposed and Edie Stout seconded a motion to accept the minutes of the March meeting.

#### Treasurer's Report

Steve Bartlett presented the financial report for the month of March 2023. Income for the month was \$48,943.52. Regular recurring expenditures for March included: \$15,287.44 to LCS Landscaping for Landscaping and Snow Removal: \$2,303.32 to Royal Carting for Refuse; \$343.00 to Central Hudson for Electricity and Gas; \$8.20 to Verizon for Telephone; \$213.22 to City of Poughkeepsie for Water/Sewer. Other expenses were \$1,942.64 to Shawn Painter for Tree removal and Stump Grinding at #94-#96; \$474.91 to Donna Augustine for reimbursement for purchase of 2 laser units; \$52.13 to Donna Augustine for reimbursement of Purchase of 2 laser units.

As of March 31, 2023 the balance of the Checking Account is \$110,767.34. The total in Checking/Saving was \$294,958.54. The total in Reserve Accounts was \$184,191.20. Donna Augustine made a motion to accept the Treasurer's report with a small correction and Janet Ellsworth seconded.

#### **Corresponding Secretary Report**

The board reviewed the status of the current Action Items presented by Janet Ellsworth. There were complaints of lawn damage from LCS snow plowing and Peter Rae asked LCS to address as part of their spring cleanup.

The bridge at the end of the pond between Muirfield and Turnberry Ct's is showing its age and needs to have some railings replaced. Joey Lapolla will provide an estimate for doing the repairs.

Edie Stout consulted with Victor Salamone from Adams Landscaping about what kinds of trees would be appropriate to replace the two pin oaks trees that were removed from #95- 96 Turnberry Court. He said there were a few options but they would have to be small. He will send me a list of possibilities.

There was a request for No Mow May to encourage areas with natural pollinators. No Mow May's goal is to pause mowing during the month of May allowing flowers to bloom in your lawn to help early season pollinators. The board decided that this would not take place this year because they want to discuss the Pros and Cons of this with the whole community at our October meeting.

The next meeting of the HOA board will be on 5/8/2023 at 70 Muirfield Ct. at 3:00 PM. The Board meeting was adjourned at 4:38 PM by Donna Augustine and seconded by Brenda Berry
